

## **DECREE 0232 OF 2026 (APRIL 6)**

“Whereby a member is appointed to the Board of Directors of the State industrial and commercial enterprise Empresas Públicas de Medellín E.S.P. - EPM”

### **THE MAYOR OF MEDELLÍN**

In exercise of his legal powers, especially those conferred by Article 97 of Decree 883 of 2015 and by Municipal Agreement 012 of 1998,

### **WHEREAS**

The Special District of Science, Technology, and Innovation of Medellín, as a territorial entity, in accordance with Articles 313 and 315 of the Political Constitution, in conjunction with Law 489 of 1998, has created various service-based decentralized entities to support the fulfillment of its constitutional and legal functions.

Decree 883 of 2015, as amended by Municipal Agreement 1 of 2016 and Decree 863 of 2020, regulated matters concerning the structure and operation of the district administration, particularly the adjustment of the structure of certain service-based decentralized entities to the Public Conglomerate Model of the Special District of Science, Technology, and Innovation of Medellín and the Land Use Plan.

Article 97 of Decree 883 of 2015 provides that the administration of Empresas Públicas de Medellín E.S.P. - EPM shall be the responsibility of the Board of Directors and the Manager appointed by the Mayor of Medellín.

Article 7 of Municipal Agreement No. 012 of 1998, “[b]y which the bylaws of the industrial and commercial enterprise *EMPRESAS PÚBLICAS DE MEDELLÍN E.S.P.* are adopted”, provides that the Board of Directors of the entity shall be composed of the Mayor of Medellín, who shall preside over it, or the delegate designated by the Mayor to replace him during temporary absences; five (5) individuals freely appointed by the Mayor of Medellín; and three (3) individuals likewise chosen by the Mayor from among the control spokespersons registered with the Development and Social Control Committees for Residential Public Utilities.

Given that one of the positions corresponding to the individuals freely appointed by the Mayor of Medellín is currently vacant, it is necessary to proceed with the corresponding appointment.

For the purposes of the appointment, the corresponding verification of disciplinary, judicial, and fiscal records was carried out. Additionally, the candidate’s curriculum

vitae was duly validated by Empresas Públicas de Medellín E.S.P., in accordance with the procedures established by the entity for that purpose.

Therefore, the Mayor of Medellín;

### **DECREES**

**Article 1. *Appointment.*** Appoint, as a member freely appointed by the Mayor of Medellín, to the Board of Directors of the State industrial and commercial enterprise Empresas Públicas de Medellín E.S.P. – EPM, Mr. ANDRÉS BERNAL CORREA, holder of Citizen's ID No. 98.557.227, in accordance with Article 7 of Municipal Agreement 12 of 1998

**Article 3. *Communication.*** Communicate this decree to Mr. ANDRÉS BERNAL CORREA and to Empresas Públicas de Medellín E.S.P.

**Article 4. *Publication.*** Publish this administrative act in accordance with the provisions of the paragraph of Article 65 of Law 1437 of 2011, as amended by Article 15 of Law 2080 of 2021.

**Article 5. *Entry into Force.*** This decree shall take effect upon its publication.
